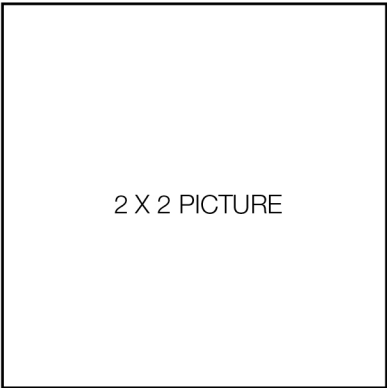

RESELLER PROGRAM AGREEMENT

This Agreement made and entered into this \_\_\_\_\_ in \_\_\_\_\_ by and between:

("COMPANY") : United Steel Technology International Corporation (Steeltech), and  
 ("RESELLER") : \_\_\_\_\_ (Name/s)

The Steeltech Reseller Program grants individuals the right to become distributors/resellers of the COMPANY's product even if they are not in the hardware or roofing dealership business. Under this Program, the COMPANY agrees to:

- Sell its products to the RESELLER at wholesale price;
- Grant Incentives/Rebates to the RESELLER. The Incentives/Rebates may be changed by the COMPANY from time to time, upon adequate notice to the RESELLER;
- To provide the RESELLER the necessary marketing materials to aid him in advertising the COMPANY's products.

The RESELLER agrees to:

- Obtain all licenses/permits/documents necessary for him to engage in the business of reselling/distributorship of the COMPANY's products;
- Purchase the COMPANY's products exclusively for the purpose of retail selling;
- To pay in advance the COMPANY for orders made on behalf of his clients. Payment may be made in cash or in cheque addressed to United Steel Technology International Corporation.

Both parties likewise understand and agree to the following LIMITATIONS:

- The RESELLER is 18 years old and above.
- There is no Employer-Employee relationship between COMPANY and RESELLER by reason of the latter's membership in the program;
- RESELLER does not enjoy exclusivity of distribution of the COMPANY's products for being listed under this program;
- The RESELLER's membership in the program does not make him an Agent of the COMPANY. As such, the RESELLER does not have the right to bind the COMPANY under any other obligation;
- The RESELLER is an independent retailer and shall have sole discretion on how and to whom to resell the COMPANY's product. However, the COMPANY's products may only be sold within the Philippines. The COMPANY does not allow the RESELLER to advertise the product through the internet or any other international publishing or media which may give the impression that it can be sold outside Philippine territory;
- Ordered products may not be cancelled by the RESELLER. Otherwise, the cost shall be charged against the RESELLER's account;
- The COMPANY's products may not be sold above the suggested retail price (SRP);
- A husband and wife tandem shall be listed as one RESELLER;
- The RESELLER shall be responsible for the payment of income taxes resulting from the sale of the COMPANY's products;
- Either party may terminate this Agreement, with or without cause, upon reasonable written notice to the other;
- All disputes, controversies and claims arising out of, or in connection with this Contract shall be filed exclusively with the proper court in the City of Manila, to the exclusion of all other venues, and shall be governed and construed in accordance with Philippine laws.
